

**HEUSSEN: Legal Consulting for Hamburg-based reconcept Involving Bond Issue**

Headquartered in Hamburg, Germany, investment company reconcept has issued a bond for its latest wind energy project ("*reconcept 07 Anleihe der Zukunftsenergie Wind Deutschland GmbH & Co KG*"). At a volume of 7.75 million Euros, the bond comes with a 5-year maturity and a fixed interest rate at 5% p.a.

The issuer is also currently in negotiations to acquire Märkische Windkraft 80 GmbH & Co. KG (anchor investment), the operator of the Mertensdorf wind farm in northeast Germany. In its quest for potential investment projects, reconcept has been eyeing other onshore wind power plants in Germany as well.
