HEUSSEN: Ranked Among the Best in Public Procurement Law by WiWo

September 23, 2019: German business weekly *WirtschaftsWoche* (WiWo) announces the outcome of its quest for the best among German law firms in the field of public procurement law. And, like it did back in 2014 and 2018, WiWo once again ranks the public procurement law practice of HEUSSEN and its partner Uwe-Carsten Völlink among its top picks for this year.

So how does WiWo make its top picks? For this year's list of top law firms/lawyers in public procurement law, WiWo hired local research institute *Handelsblatt Research Institute* (HRI) to conduct a survey asking 506 lawyers from 72 firms to name the most renowned fellow lawyers they could think of. The complete list of names was then handed to an expert jury, which narrowed it down to its final outcome of 49 law firms with 69 most highly recommended lawyers.
